The applicant hereby grants to the cooperative, its successors and assigns, the right to construct, and an easement to operate, repair and maintain on any lands owned by the applicant, its electric distribution and service lines and appurtenances.

The applicant agrees for the cooperative to cut, remove or trim trees and undergrowth within its designated right of way. The applicant further agrees for the cooperative to apply herbicide to control the growth of brush or trees within designated right of way.

The applicant will cause his premises to be wired and operated in accordance with specifications adopted by the cooperative.

The applicant will comply with and be bound by the provisions of the by-laws, rates, policies, service, and the rules and regulations of the cooperative in effect and as modified from time to time by the cooperative. In the event applicant fails to comply as stated above, membership will be terminated.

The applicant agrees that membership in the cooperative is contingent upon approval by the cooperative.

The approval of this application by the cooperative shall constitute an agreement and a contract between the applicant(s) and the cooperative, which shall continue in force from the date service is made available by the cooperative to the applicant(s), until terminated by either party.

I acknowledge that everything I have stated in this application is correct to the best of my knowledge and I authorize Pioneer Electric Cooperative, Inc. to check my employment and credit history to obtain credit reports now and in the future in connection with this application. In the event that I do not have to pay a deposit upon submitting this application, I understand that I may be required to pay a deposit in the event I fail to make required payments in a timely fashion.
